Board discussed extending the three month probationary period that had been originally set for Assistant Part-time Court Clerk Tom Ingram. It was mentioned that the main concern is with him having recently begun another part-time job it limits his availability especially while Full-time clerk is catching up on the backload. Trustee Graham mentioned it was his understanding that Mr. Ingram is still needed at this time and has been working on archiving, helping on Court nights, etc. This was confirmed by Clerk Yasses. It was suggested tracking any overtime incurred by Ms. Yasses due to limited availability of Mr. Ingram and reevaluate in another three months.

Trustee Peterson addressed the Board with a statement regarding the DWI grant suspension issue saying he went to the county to question proper procedure for submission of DWI vouchers for the grant. He said he had not requested an investigation by the State Police.

He said the question was prompted by an officer informing him that on one occasion he would not sign his time card because he felt it was misrepresented as indicating he was on DWI patrol when he wasn't. Trustee Peterson said he had received copies of the DWI reimbursement forms and had ascertained that many of the reimbursements were not for designated DWI patrols. In his statement he alleged that there was a possibility of fraud by the mayor and deputy mayor. He said the reason he did not go to the Board first

with this issue was because he has been treated in a hostile manner and verbally attacked and insulted.

Mayor Skeet mentioned the Village has been receiving DWI grants for close to ten years and the Stop DWI coordinator Frank Ciacia had never had a problem with the procedure followed by the Village for reimbursement prior to this and mentioned the forms were filled out the way Mr. Ciacia indicated at a meeting when he and the Clerk met with Mr. Ciacia several years ago. It was also mentioned that during this investigation the clerk who filled out the DWI paperwork was never questioned or approached about the procedure followed.

In his statement Trustee Peterson also said he felt that Sergeant Jim Meier should have known proper procedure for the DWI grant and asked for disciplinary action against Sergeant Meier.

Trustee Graham asked if it was proper procedure that Trustee Peterson went to civil service and changed the Police Administrator's job description without Board approval.

Attorney Mark Boylan stated that the investigation concluded with no charges being filed and no evidence of fraud. With no evidence of intentional wrongdoing there is no basis to discipline anyone.

Officer Gene Nati requested an official response that there was no wrongdoing committed by Police Officers in reference to the DWI grant. He said there were allegations that time cards were being altered and that he was approached at his home by State Police investigators regarding the DWI grant. He indicated he feels the Officers reputations may be soiled when they didn't do anything wrong and fears retaliation by cutting their hours.

The issue of missing tickets was briefly brought up and Mayor Skeet said State Police investigators found there was no wrongdoing in either case and felt that Trustee Peterson started pursuing the Stop DWI issue only after the Village Board asked State Auditors to look into potential problems with the Village Court. He also mentioned that he felt Trustee Peterson was the cause of the Village losing about \$3000.00 in DWI funding. He said if Trustee Peterson will give him a copy of his statement he will be glad to answer it. Trustee Peterson agreed he would provide a copy to the mayor.

The meeting went on with report on Maintenance department. Trustee Graham said the boys have been busy picking up branches from recent heavy rain and wind. They have also been doing maintenance on police cars.

It was also mentioned that the DEC has taken away a portion of the Sewer Grant increasing the portion the Village would have to fund. Mayor Skeet and Trustee Graham said this grant should not cost the Village taxpayers any money to hook the Town up to our plant.

Trustee Peterson asked when the Engineering concepts would be presented to the Board. He was told there is no exact time frame as yet since the design depends on if GCEDC is going to contribute or not. The forecast is they would like to start in March.

Mayor Skeet asked if there were any questions regarding the tax cap and mentioned that the proposed law does not mean the Village is going to raise taxes. Attorney Mark Boylan explained that majority of municipalities have adopted the law to avoid running afoul of the state should an emergency occur that would require a tax increase above the 2%. He also mentioned it does have to be renewed annually.

Mayor Skeet said if there were no more questions he would like a motion for adoption.

Motion was made by Trustee Graham and seconded by Trustee Bielec to move the following Resolution:

### Local Law No. #1 of the year 2012

Village of Corfu, County of Genesee

A local law authorizing a property tax levy in excess of the limit established in General Municipal Law §3-c

### **Section 1. Legislative Intent**

It is the intent of this local law to allow the Village of Corfu to adopt a budget for the fiscal year commencing June 1, 2012 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

## Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

#### **Section 3. Tax Levy Limit Override**

The Board of Trustees of the Village of Corfu, County of Genesee, is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2012 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

### **Section 4. Severability**

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the

controversy in which such judgment or order shall be rendered.

# Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.
