The following information was provided to the residents in attendance to review:

Village of Corfu, County of Genesee

A local law authorizing a property tax levy in excess of the limit established in General Municipal Law §3-c

Section 1. Legislative Intent

It is the intent of this local law to allow the Village of Corfu to adopt a budget for the fiscal year commencing June 1, 2023, that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

Section 3. Tax Levy Limit Override

The Board of Trustees of the Village of Corfu, County of Genesee, is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2023, that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal

Law §3-c.

Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

The Mayor addressed the residents to ask if there was any questions or concerns; at that time, there was no response from any residents in attendance.

Planning & Code Enforcement Update:

- Mr. Johnson reported that on Air B&B information requested:
 - o \$150 yearly fee which includes a yearly inspection including fire inspection, parking, etc.

- Mr. Johnson is currently taking the NYS required training.

- Mayor Sargent discussed the new changes to CHIPS; any sidewalk repairs to be covered under the funding would require ADA compliance by a NYS approved contractor.

- EWR reimbursement has been submitted for funding for Depot St paving project.

Sewer Update:

- Mayor Sargent informed the Board the email sent out for the Belt press project was sent in error; this is for solution for the sludge problem, however, not a planned project.
- Yancey's has been billed for service call outs for Cohocton lift station.

WWTP UV Disinfection Project:

- Mayor Sargent sent an email to the Village Board requesting their approval via email to approve authorization to bid for MRB for the WWTP UV Disinfection Project, going out with the effective date of February 6, 2023 as this needed to be completed prior to the Regular Meeting of February 8th, 2023. All Board members have responded with their approval; Village Clerk has all email responses and can be reviewed at the Village Office.
- Notices announcing the Bid have been published in the newspaper on February 4th, 2023.
- Bids will be due on March 2nd, 2023, and will require to approve the bids at the first meeting in March 2023.
- Trustee Reisdorf made a motion to approve the following resolution; 2nd by Trustee Lauer:
 Therefore, be it resolved, The Village of Corfu Board Authorizes MRB Group to Bid the Village of Corfu Waste Water Treatment Plant Disinfection Project with a bid date to be determined by the Engineer.

Mayor Sargent read the following resolution:

RESOLUTION#2 ADOPTING LOCAL LAW No. 1 of 2023

WHEREAS, proposed Local Law #1 of 2023 of the Village of Corfu entitled "A Local Law Authorizing a Property Tax Levy in Excess of the Limit Established in General Municipal Law Section 3-c", which proposed Local Law in its final form was presented to the Village Board at the meeting held on January 25, 2023, and a copy thereof was kept with the Village Clerk and copies both laid upon the desks of the members of said Village Board; and **WHEREAS** a public hearing on the advisability of enacting said proposed Local Law was held on February 8, 2023, before this Village Board, pursuant to Public Notice duly published in The Daily News according to Law, at which all interested persons were heard; and

WHEREAS, the Village Board of the Village of Corfu, New York is of the opinion that the adoption of said Local Law #1 of 2023 is in the best interest of the Village of Corfu, New York,

NOW THEREFORE BE IT RESOLVED, by the Village Board of the Village of Corfu, New York that said proposed Local Law #1 of 2023 be and the same hereby is adopted; and **BE IT FURTHER RESOLVED** that a certified copy of said Local Law #1 of 2023 be filed with the New York State Secretary of State in accordance with Law.
