Mayor Sargent read the Local Law #1 of the year 2022: Village of Corfu, County of Genesee

A local law authorizing a property tax levy in excess of the limit established in General Municipal Law 3-c

Section 1. Legislative Intent

It is the intent of this local law to allow the Village of Corfu to adopt a budget for the fiscal year commencing June 1, 2022, that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law 3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

Section 3. Tax Levy Override

The Board of Trustees of the Village of Corfu, County of Genesee, is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2022, that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law 3-c.

Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the

court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.

The public hearing remained open for a portion of the Regular business meeting of the Village.

Planning and Code Enforcement:

- No update of 9 West Main Street at this time
- Received application for Code Enforcement and Zoning Officer; will work with civil service to get
 qualifications. Mr. Waff recommended that the "Code Enforcement Officer" title should be changed to
 "Code Compliance Officer". He felt that the title of enforcement is intimidating, and this position
 should be working with the public to help with NYS requirements. The Board agreed to recommend
 changing the title of the position.

Police Update:

- Received letter from Police Department to open negotiations of the new contract that is soon to expire.
- Mayor Sargent and Deputy Mayor Doktor will be on the negotiation committee.
- Mayor and Deputy Mayor, along with Officer in Charge and Officer Retzlaff interviewed a candidate for the Department; they will request the candidate to come to the next Board meeting.
- Discussed meeting with Darien Lake regarding the traffic situation that occurs in the Village during the season. Darien Lake is planning on 35 concerts for upcoming season.
- Town of Darien is working on a proposal to hire Village of Corfu PD for their court proceedings.

- Mayor Sargent requested Drave's Tree Service to review trees throughout the Village for upcoming issues.
- Deputy Mayor Doktor has reached out to NYS DOT with no response. Trustee Reisdorf suggested to reach out to Steve Hawley's office as the DOT has not responded after several attempts.
