

Village of Corfu Regular Meeting Minutes February 10, 2021

The Village of Corfu Board of Trustees held the Regular Monthly Meeting at the Corfu Village Hall, 116 East Main Street on February 10, 2021 at 6:30 p.m. Present were Mayor Sargent, Deputy Mayor Graham, Trustee Lauer, Trustee Reisdorf, Village Clerk, Jennifer Eck, and Planning Board Chairman, Mark Zimmerman. Trustee Doktor was absent.

Planning Update:

- Mr. Zimmerman discussed with the Board the requirements to hold a Special Hearing for the Special Use Permit for NYS rules
- Due to the Covid-19 Restrictions the public hearing for 18 East Main Street it was decided to be waived
- Discussion regarding fees for the Special Use Permit; the permit will be required to be renewed on a yearly basis; the planning board will discuss a fee recommendation
- 18 East Main Street will need to be inspected and renewed with a fee; however, the Board will waive the first year's fee for 18 East Main due to the fee has not been instituted to date
- Mr. Zimmerman would like to create a survey for the Village Residents to get their ideas and recommendations for the community; he will send to the Board for approval

Mayor Sargent made a motion to waive the Public Hearing for the Special Use Permit for 18 East Main Street due to Covid-19 restrictions; 2nd by Deputy Mayor Graham

Sewer Update:

- Trustee Reisdorf discussed the need for a Comprehensive Plan with the Town of Pembroke and Village for the Sewer plant
- Mayor Sargent and Deputy Mayor Graham met with Town of Pembroke Supervisor, Tom Schneider regarding a plan; Mr. Schneider will consult with the Town's Attorney, Mark Boylan for this plan
- Start up for the new plant has been postponed; possible March startup
- Cable will be installed down Fieldcrest unknown date at this time
- Roof is leaking in Clarifier room; roof is flat last repair was in the 1990's
- Blower has been taken down and delivered to Bailey's for repair
- Trustee Reisdorf discussed Camden Contract on the acceptance; Mayor Sargent wants to hold off on the contract as there are many caveats to the contract and plants; once a decision is made on all plans with the plants, it will be signed
- Deputy Mayor Graham discussed all the different decisions that will need to be made including approval with DEC and Town of Pembroke

Beautification Update:

- Katy Hobbs submitted budget; basic min of needs is \$3,000 for the upcoming Farmer's Market

- Trustee Reisdorf spotlighted Katy Hobbs and Matt Steinberg on all the work they did for last year's market
