  - Pump for EQ tank has been ordered; Town of Pembroke is paying for this.
  - Waiting for STC to work on Clarifier building.
  - Scott Turner put rocks at Cohocton Road lift station.
- Village/Town Meeting
  - Darien has been approved to move forward with project.
  - Meeting with MRB for work to be completed at lift station.
  - Village has not approved Darien to connect at this time; Darien needs to meet our engineering requirements and discuss financial impact.
  - Town of Pembroke entered into an agreement with Camden Group to pay directly for new plant repairs.

- Sending out applications for Autumn in the Village; next meeting in April.
- Will be sending out Flowerpot donation notices to businesses in approx. 2-3 weeks.
- Village wide yard sale scheduled for May 31-June 1.

- Mayor Sargent and Deputy Clerk met with Town of Pembroke Board members, Tom Dix and Ed Arnold to discuss the lease agreement. Town will hold a meeting next week and they will discuss with the Board after said meeting.
- Mayor Sargent requested changing the tree line to \$10,000 for upcoming budget; need to discuss about reserve line for sewer.
- We have been awarded the Murder Creek grant for \$50,000.
- Discussed NY forward grant; very complex grant.
- All paperwork is complete to close on property; should close in couple weeks.
