Misc:

- Eclipse event was a huge success; different people at every event, School was a great help.
- Deputy Mayor Doktor spoke with the Historian regarding QR codes to scan so people can download pictures and information on homes.
- Pam Ware spoke to the Board on a pilot program with NYS for seniors regarding the older Americans act; will discuss further with Mayor Sargent.
 - On February 6, 2024, ACL released a final rule to update the regulations for implementing its Older Americans Act (OAA) programs. The new regulations will take effect on March 15, 2024, but regulated entities have until October 1, 2025 to comply. ACL looks forward to working with partners in the aging network to implement the final rule and will provide robust technical assistance and other resources to support states, tribes and tribal organizations, area agencies on aging, and others in the aging network in meeting its requirements. The first substantial update to most OAA program regulations since 1988, the rule aligns regulations to the current statute, addresses issues that have emerged since the last update and clarifies a number of requirements. It aims to better support the national aging network that delivers OAA services and improve program implementation, with the ultimate goal of ensuring that the nation's growing population of older adults can continue to receive the services and supports they need to live and thrive in their own homes and communities.
 - Among other things, the final rule clarifies provisions for meeting OAA requirements for
 prioritizing people with the greatest social and economic needs; addresses emergency
 preparedness and response; establishes expectations for legal assistance and activities to
 prevent elder abuse; and clarifies the role of the aging network in defending against the
 imposition of guardianship and in promoting alternatives to guardianship.
