

Village of Corfu Regular Meeting Minutes Public Hearing for 2022-2023 Budget Public Hearing for Sewer Rate increase April 13, 2022

The Village of Corfu held its Regular Meeting on April 13, 2022, at 6:30 p.m. at located at 116 East Main St, Corfu NY 14036. In attendance: Mayor Sargent, Deputy Mayor Doktor, Trustee Lauer, Trustee Reisdorf, Village Clerk, Jennifer Eck, and Village Electrician Norman Waff. Trustee Johnson was absent

At 6:30, Mayor Sargent opened the public hearing for the 2022-2023 Budget hearing and the public hearing for the sewer rate increase.

Planning and Code Enforcement:

- Brittany's Booze barn have been approved from the NYS Liquor Authority and plan a 4/22 opening
- Discussed the 2 candidates for the Zoning & Code Enforcement Officer; Mayor Sargent and
 Trustee Reisdorf have interviewed both candidates. The Mayor and Trustee are recommending
 Mr. Johnson for the position as he has plenty of experience and time to dedicate to the Village.
- Town of Pembroke has been handling issues in the Village at this time, there has been a couple items they are attending to.
- Discussed Trustee Lauer's suggestion on absorbing Town of Pembroke's permit fees. Mayor Sargent will have planning board review and submit any changes to the Board
- Mayor Sargent will have planning board review agreement with the county on certain exemptions on permit approvals.

- Have reached an agreement with Town of Darien to have Village of Corfu Police handle their court; at a fee of \$39 per hour, guaranteed 4 hours each court session, with 5 court dates a month.
