Resolution of Authorization and Project Costs for Award Allocations

WHEREAS, the Village of Corfu submitted and was awarded an Engineering Planning Grant (EPG) under the Consolidated Funding Application (CFA) process on behalf of the Village, for upgrades to their WWTP Disinfection Project; and

WHEREAS, the New York State Department of Environmental Conservation and the New York State Environmental Facilities Corporation offer a competitive statewide reimbursement grant programs for local governments, administered through the New York Clean Water State Revolving Fund; and

WHEREAS, that the Village of Corfu Board Trustees, accepts the EPG program grant award on behalf of the Village for WWTP Disinfection Improvements; and

NOW THEREFORE BE IT RESOLVED, that Mayor Thomas Sargent is authorized to execute a Grant Agreement with the NYS Environmental Facilities Corporation and any and all other contracts, documents and instruments necessary to bring about the project and to fulfill the Village of Corfu's

obligations under the Grant Agreement; and

BE IT FURTHER RESOLVED, that the Village of Corfu authorizes and appropriates a minimum 20% local match as required by the Engineering Planning Grant Program for the WWTP Disinfection Improvements. Under the EPG program, this local match must be at least 20% of the EPG grant award of up to \$30,000. The source of the local match, and any amount in excess of the required match, shall be provided through the sewer fund. The maximum local match shall not exceed \$6,000 based upon a total estimated maximum project cost of \$30,000. The Mayor may increase this local match through the use of in kind services without further approval from the Village Board.
