

Village of Corfu Regular Meeting May 13, 2020

The Village of Corfu Mayor held its Monthly Committee Meeting at the Corfu Village Hall, 116 East Main Street on May 13, 2020 at 6:30 p.m. Present were Mayor Sargent, Deputy Mayor Graham, Trustee Lauer, Trustee Reisdorf, Trustee Doktor, Village Clerk, Jennifer Eck, and Glenn Eck.

The meeting was opened at 6:30 pm followed by the Pledge to the Flag.

Planning Update:

- Trustee Reisdorf informed the Board that the Farmer's Market project is coming together
- The committee has chosen Katie Hobbs to manage the Market and the official opening date is planned for July 6, 2020 with the location at the Corfu Presbyterian Church.
- Resident, Matthew Steinberg has volunteered his time in creating a logo and signage
- Village Clerk has reached out to insurance company to add location to the policy
- Remodeled house on Long's Lane is almost completed; homeowner will be putting house on market soon
