

# Village of Corfu Regular Meeting June 10, 2020

The Village of Corfu Board held its Monthly Committee Meeting at the Corfu Village Hall, 116 East Main Street on June 10, 2020 at 6:30 p.m. Present were Mayor Sargent, Deputy Mayor Graham, Trustee Lauer, Trustee Reisdorf, Trustee Doktor, Village Clerk, Jennifer Eck, and Mark Zimmerman.

The meeting was opened at 6:30 pm followed by the Pledge to the Flag.

#### Planning Update:

- Trustee Reisdorf informed the Board that Katy Hobbs and Matthew Steinberg are working diligently on the rules and regulations for the Farmer's Market; Board recommended Trustee Reisdorf contact
   Village Attorney, Whiting Law Offices for help regarding the vendor contract
- Katy Hobbs has put out a mass email for vendors to apply
- Farmer's Market tentative date will be Monday, July 13, 2020.
- Mark Zimmerman discussed the inspection and permit fees were updated in 2015-2016; will review other municipalities for a possible update to the permit fees
- Mr. Zimmerman recommended that an updated permit application be created and uploaded to the Corfu Website
- Deputy Mayor Graham recommended to the Board to initiate a permit for Contractors for the Village with their license, insurance and a fee attached
- Deputy Mayor Graham informed the Board of a resident complaint at Thompson and 33 regarding a neighbor's fence; Zoning Officer is investigating complaint
- Zoning Officer has 2 pools being installed in the Village
- Mark Zimmerman has spoken with Genesee Co regarding rezoning; as long as we are compliant with our comprehensive plan and the Genesee Co Smart Plan, we can move forward with rezoning
- Mayor Sargent spoke with Mr. Schmigel regarding his property; he is willing to sit down with Board and discuss future of his property
