

Village of Corfu Committee Meeting June 24, 2020

The Village of Corfu Board held its Monthly Committee Meeting at the Corfu Village Hall, 116 East Main Street on June 24, 2020 at 6:30 p.m. Present were Mayor Sargent, Deputy Mayor Graham, Trustee Lauer, Trustee Reisdorf, Village Clerk, Jennifer Eck. Trustee Doktor was absent.

The meeting was opened at 6:30 pm followed by the Pledge to the Flag.

Planning Update:

- Mayor Sargent submitted a report from Trustee Doktor; he reviewed 3 municipality fees for their statement of fees from building permits and our fees are on target with all others
- Trustee Reisdorf informed the Board that Katy Hobbs has created a manual for the Farmer's Market
- 4 Vendors have committed to the market and on schedule for the July 13th start
- No information from Ron Long

Police Update:

- Mayor Sargent stated some Officers are starting to schedule themselves for shifts
- Informed the Board on a incident that had happened within the Village that Genesee County Sheriffs Department handled (due to no Officers on duty in the Village); due to the incident, the Village Police Department is requesting a Taser
- Discussion regarding policies and procedures must be created before the Board will consider the purchase; Mayor Sargent will discuss with Officer Reeves
- Mayor Sargent will be interviewing potential Officers on Monday
- Mayor Sargent discussed the idea to eliminate the seniority aspect as far as a scheduling standpoint for the next contract; will have a meeting with Officers and Union in the upcoming weeks
- Discussed the policy for Officers requesting Time Off; Union has a formal document that the Officers are to use; if this document isn't completed, they could be in jeopardy of termination

Court Update:

- Received letter from Judge O'Connor stating records are available for Court Audit
- The Board discussed the Court Audit; Clerk will reach out to Attorney's to see if they could pursue the audit
- Court has no official date to open for proceedings

Maintenance Update:

- There have been piles of brush throughout the Village that residents have included garbage and lumber; Deputy Mayor Graham asked to put a reminder in newsletter regarding this
- Signs have been installed on Depot St at the Train crossing
- Received notice from Chip stating fund balance; Chips \$43,908
- Discussed letter from Library requesting a sidewalk and handicapped parking spot; the Board will stop

at location and discuss what the Village can do

 Discussed the curb needed in front of Buttercrumbs; Deputy Mayor Graham will get quote and contact the NYS DOT for approval

Office Update:

- A resident sent a gift of masks to the Village for the office, police and fire department; Mayor Sargent will send a thank you letter
