

Village of Corfu Committee Meeting Minutes June 28, 2023

Planning and Code Enforcement:

• Mr. Johnson sent a letter to D&S; at this time but there has been no response; Trustee Krzemien inquired as to what the planned end result would be, Mayor Sargent stated that the Board would like to see all rules and regulations are met to ensure safety.

Police Update:

- Officer in Charge, Mr. Krzemien, discussed The City of Batavia reached out to notify CPD they are selling a SUV for \$10,000; 130,000 miles with light package Inspections have been completed and have negotiated a price of \$8,000.
- Our new Officer has started. She is presently in Phase 1 of FTO training.
- Concert traffic has increased; the Officer towed 6-8 vehicles on average.
- Charlie Lenhard, Crossing Guard has informed the department of an increase of vehicles violating traffic laws and running the red lights; Officer Krzemien will put patrols on corner.
- Charlie Lenhard, inquired on new paint at intersections.
- Department has applied for grants; Vest and Traffic

- Discussed MRB Proposal Evaluation; \$6,000 they will come once work commences with the UV Project to evaluate project.
- Sewer Account- Transferred the \$25,000 from General Fund to Sewer Fund on 6/22/2023 per motion to approve 2nd loan at the May 24, 2023, Meeting.
- Per Municipal Solutions the amount due for reimbursement to the Village is now \$86,029.85. The EFC has a tentative closing date of Aug 3, 2023, and then the reimbursement request can be submitted.
- Mr. Schollard discussed the dumpsters were delivered on the wrong day and clean up has been completed.
- Mr. Schollard discussed vacuum pump at Cohocton lift station was rebuilt; Deputy Mayor Doktor inquired on generator causing issues.
- Deputy Mayor Doktor inquired with the excessive rain how the plant is keeping up, Mr. Schollard stated all is good, however, does recommend smoke testing soon.
