- New lab equipment is in; will train at Oakfield plant.
- Oven gives accurate readings for the MLSS & SVI numbers
- Fixed 2 pressure washers, new hose reel on the steam washer
- PM done on both-skid loaders and lawn mowers
- Relay switch for vacuum pumps replaced at Cohocton Road pump station
- Replaced air filters on all 5 blowers
- Penn Power did PM's on all generator's
- Lab scale cleaned and calibrated
- 02 sensor went bad on gas meter in the influent chamber
- Submitted 2 quotes from Cold Spring Environmental and Koester for new sensors (Cold Spring -\$1,858; Koester - \$3,569)

Police:

Norm Waff's Report: (Maintenance)

- 1. Old Items:
 - a. FCC License still in progress Continues
 - b. Photo inventory is still on-going Continues
 - c. Down spout splash blocks have been ordered

These are being completed with the extra concrete left over from their normal manufacturing process. This means they'll cast a few each week and deliver them when the order is complete.

- d. Material for the overhead door repair in the South Maintenance Building has begun on the north garage door. All work on both doors is expected to be completed by the July 27th Board Meeting.
- 2. Concrete flat work behind the Police Garage measures 5' wide and 50' long. Concrete work must be completed by the last week in August to allow for a 28 day cure on the concrete prior to the earliest possible freeze date of the weather in October. **Status?**
- **3.** The plan for building a mezzanine in the north end of the East Drying Bed of Corfu #1, for winter storage of the flowerpot boxes is in for materials pricing and we're awaiting costs.
- 4. The rear gate has been locked next week.
- 5. Corfu #2: Status?
 - a. The door to the Influent Room still does not latch. This is a life safety concern.
 - b. The door to the Blower Room does not latch.
 - c. The Control Room and the Blower Room were designed to each have an emergency/night light fixture installed. There is no night light function in either room. This needs to be corrected as the blower room is windowless and you enter in total darkness.

NEW ITEMS for 7/13/22

- 1. Working on electrical connections to the boom hoist to make it operational again. We believe we've narrowed it down to a relay issue.
- 2. Repaired electric pressure washer. Replaced the pressure relief valve.

Court Update:

Office Update:

- Clerk has received \$35,948.60 ARPA Funds
- 96% of Village Property Taxes have been collected
