Officer Retzlaff arrived at the meeting at 6:49 pm. He presented some research he had done on Tasers. He said he had spoken with Chief Dibble of the Genesee County Sheriff's Office who informed Officer Retzlaff that approximately half of the Village Officers are trained on the current style of Taser.
