

Village of Corfu Regular Meeting Minutes August 11, 2021

The Village of Corfu Board of Trustees held the Monthly Regular Meeting at the Corfu Village Hall, 116 East Main Street on August 11, 2021, at 6:30 p.m. Present were Deputy Mayor Doktor, Trustee Lauer, Trustee Johnson, Trustee Reisdorf, Village Clerk, Jennifer Eck, and Village Electrician Norm Waff. Mayor Thomas Sargent was absent.
