Deputy Mayor Bielec opened the Regular meeting at 6:35 pm in the absence of Mayor Peterson. The meeting began with the Pledge of Allegiance.

Members present: Deputy Mayor Bielec, Trustees Busch, Ianni and Lauer, Officer Retzlaff, Harvey Stalker from Corfu Presbyterian Church and several residents.

Harvey Stalker, representing the Corfu Presbyterian Church, spoke to the Board regarding difficulty he is having trying to contact Code Enforcement Officer John Good. He said the church has put in an application to take care of several structural issues at the church affecting the health and safety of their parishioners. He said in the absence of hearing from the Code Enforcement Officer, the church intends to start work. He added that the work would be augmenting what is already there with no changes in structure. He outlined a few of the issues including a mold problem developed by leakage, having to excavate and put in some block wall, waterproofing and some front portico work. He said they would gladly have Mr. Good look at the work as they proceed.

Deputy Mayor Bielec said he would give John Good a call. Mr. Stalker left the meeting at 6:38 pm.

Village resident Mike Tost also spoke up regarding Code Enforcement Officer Good. He said besides the continuing mess and potential safety issues outside Petals and Plants, there are also still several fire code violations within the building. No permits are on file with the Village for any work done at that location in the past seven years which includes adding an additional apartment on the first floor, the lean-to added to the west side of the building or the extra greenhouse added to the west. Mr. Tost informed the Board that he wants some action taken in the next 72 hours or he will contact the media. He added that it has been four years since the tornado and when Petals and Plants did go before the court in 2010 they were given an extension, but there appears to be no follow through after the extension was given.

Trustee Busch questioned why it took Mr. Tost four years to come to the Board with this. Trustee Busch was informed that he has been coming to the Board all along but has not seen any results. Deputy Mayor Bielec said he would also speak to John Good regarding this issue.

Mt. Tost left the meeting at 6:45 pm.

It was felt some confirmation was needed from the Mayor that he intends to follow the doctor's advice. Trustee Ianni suggested rather than have the Attorney contact the Mayor, he would like to contact him first to request a letter directly from the Mayor. When questioned, Trustee Ianni added he will also request that the Mayor consider resigning.

The discussion turned to whether it would be worth the expense to pursue follow up with the State Appellate Court should the Mayor refuse to resign as it is an expensive procedure and would likely take a considerable length of time. It was also brought up that the Village will still have to pay the Mayor while he is on medical leave.

Resident Linda Tucker questioned how he can be on medical leave from one job and not his other job.

Clerk gave an update on status of uniform order made for unhired officers. She had been informed that one officer's uniforms had been paid for directly and that as yet there had been no record at United Uniform of the other officer's uniforms being returned.

Clerk also updated the Board on further orders by officers that have exceeded their allotted uniform allowance. She requested permission to send those officers that have exceeded their allotted uniform allowance letters of how much they will be required to reimburse the Village for the overage.
