The Board shall hold other regular meetings at such times and places in the Village as it shall by resolution provide. Special meetings ay be called by the Mayor or any two Trustees, by causing a written notice, specifying the time and place thereof, to be served upon each member of the Board, personally, at least one hour, or by leaving a notice at his/her residence or place of business with some person of suitable age or discretion, or by email, at least twenty-four hours before the time of the meeting, or by mailing such notice at least seventy-two hours before such meeting. Any meeting may be adjourned to a later date, but not more than three (3) weeks. (See Section 87 of Village Law)

Planning Update:

- Trustee Reisdorf informed the Board that 18 East Main Street has requested a zoning variance; it was decided that the zoning variance is inadequate and was instructed to complete a special use permit.
- Mayor Sargent informed Trustee Reisdorf that this process should continue to proceed

Police Update:

- Mayor Sargent informed the Board that Officer Labelle has completed FTO training; it was explained to the Board he needed 160 hours within 5 weeks

Court Update:

- Received \$15,917.50 for September 2020 Fines
- Audit has been finalized with Comptroller's Office

Maintenance Update:

- Camden Group Representative, Glenn Eck was approached by a resident on Ganson Ave inquiring why a streetlight has been removed; Mayor Sargent will reach out to National Grid for more information
- Lawrence Ave resident has complained that the new lights installed are too bright; Mayor Sargent will
 request a shield for the resident, however, is waiting until all lights are installed to make sure no other
 shield are needed to be installed
- Mr. Eck spoke to the Board regarding plowing of Ganson Ave; Town of Darien does not plow all the way to the end of road, Mr. Eck wanted permission to reach out to Town of Pembroke to complete this when plowing to ensure the residents are able to get out of their driveways
- Village Truck should be ready in 2 weeks
- Mr. Eck asked if the Village can advertise that leaves after Thanksgiving need to be bagged
- Mr. Eck informed the Board that a man door for the Police garage is needed, approx. \$750
- Mr. Eck received a quote from Niagara Equippers to install lighting on truck with a quote of \$1,670.45;
 Mr. Eck has inquired with FM Communications and Rebel liners, neither company has responded to the quote request.

Deputy Mayor Graham made a motion to approve Niagara Equippers to complete the lighting project for the Village Truck, with the attempt of requesting other quotes Deputy Mayor Graham stated no other written quotes will be needed; 2nd by Trustee Doktor
