She gave some examples of current interest rates. She mentioned that as of March 2013 they will utilize the 2010 census figures. She said that the loans can be used to purchase existing buildings as well as renovations. When questioned whether this could be utilized for purchase of property she responded that it could not for property alone, but could be for property and a building that would go on the property. She briefly outlined the application procedure.

Ms. Kuras also gave information on Water and Sewer Loan and Grant Programs, noting that these can be used for updates on equipment and parts. Trustee Graham mentioned the cemetery lift station which needs upgrades. Ms. Kuras suggested getting DEC to provide a letter outlining health hazards if it is not upgraded. Ms. Kuras also handed out a listing of multiple other financing programs available.

Dawn Kuras left the meeting at 7:40 pm.

Brief discussion took place regarding taking a look at the cemetery lift station as a project. It was mentioned that it needs to be made bigger with larger pumps. Other ideas were possibly for the purchase of a dump truck or leaf vacuum.
