Deputy-clerk updated the board on the closing of the serial bond. Greene County Commercial Bank arranged the wire transfer of \$207,400 for the Bond proceeds on December 8, 2016. The Village arranged the payoff of \$368,500.54 (principal - \$362,180 and interest – 6,320.54) of the Note (dated December 9, 2015 to December 8, 2016) to Greene County Commercial Bank. Transactions were completed with M&T Bank.

Trustee McMartin-Eck gave an update on the court. The field work for the audit has been completed. They are waiting for Dave to write up the final report.

Trustee Graham gave an update on sewer. There is a potential of 40 senior living houses going in at the former Market. If that happens, the sewer plant will be at capacity.

Trustee Lauer asked when the Sewer Fund would be paying off the General Fund, as sewer has been subsidized by the General Fund. Brief discussion took place.

Deputy clerk presented letters for the Cotton property and Ross property regarding the unregistered vehicles. If the properties are not in compliance by the end of January, letters will be sent out stating that court action will be taken.

There was a brief discussion regarding Winterfest. The committee is looking at moving the Winterfest to the Intermediate School on Route 77. They are waiting for a certificate of insurance from the Village. Once received, the school will make the decision to allow the Village to use the school for the 2017 Winterfest.

Because of the holiday, the Committee meeting of December 26, 2016, will not be held. The next meeting will be January 9, 2017, at 6:30 pm.
