Trustee Peterson returned to the meeting at 6:50 pm.

Clerk informed the Board of communication received from NYCOM regarding requirements and training time for any acting justice that will be appointed. Requirement includes a Bench Certification course being

offered in Albany April 8-13, 2013. If an attorney or current justice is appointed, the training is not necessary. If a non-attorney or justice is appointed, the cost of training would be incurred in this current budget year. Discussion took place regarding advertising for the position.

Deputy Mayor Graham gave a sewer project update, mentioning that there has been talk that GCDEC wants additional capacity reserved for their industrial parks and that the truck stop is also talking about wanting to be added back into the project.

Deputy Mayor Graham informed the Board that with the current planned plant restoration to 135,000 gallon capacity, there would not be enough capacity for those requests.

Trustee Ianni questioned why they can't come to one of our meetings to update the entire Board. Trustee Peterson questioned how we can have a project when the specs keep changing.

Deputy Mayor Graham said that GCEDC won't be able to market the industrial centers without sewer and if the Truck stop wants to come in they would have to put up the funds to expand the plant.

Village Attorney Mark Boylan arrived at the meeting at 7:05 pm. He was updated on the previous conversation and said that the two Engineers need to talk. He agreed that not a dime should come out of Village residents if plant needs to be upgraded for additional capacity. He mentioned a joint sewer project committee meeting is scheduled on Tuesday, February 19<sup>th</sup> at 6:30 at the Town of Pembroke and these items will be discussed. Clerk will call in advertisement of the meeting due to additional Trustees wishing to attend the meeting.

Attorney Boylan confirmed to the Board that he will be formulating a letter to Judge Alexander regarding the Comptroller audit results of missing funds. He said that according to NYS Village Law the Justice is accountable for his Court's accounts and liable for repayment of any missing funds based on the Comptroller's audit.

Attorney Boylan left the meeting at 7:15 pm.

Trustee Ianni questioned if Judge O'Connor is elected to the Justice position, couldn't Judge Alexander be appointed as acting justice? It was reiterated that an ad will be placed for the position. Clerk was requested to check the Civil Service job description for requirements and bring the ad copy to the meeting on February 18<sup>th</sup> prior to placing the ad in the paper.

#### Gentlemen:

This will confirm our meeting held on November 29, 2012. At the meeting we emphasized that the Eighth Judicial District is responsible for assuring the orderly administration of justice at the Village of Corfu Justice Court. We emphasized that the primary responsibility is on Justice Alexander to assure that between now and March, when his term in office is up, that the court needs to run smoothly without interference by the Village Board of Trustees. It was emphasized that all parties concerned should be focused on moving forward rather than focused on events of the past several months.

The Unified Court System acknowledged and the Village Board agreed that Justice Alexander has the authority to manage the day to day responsibilities of the clerk of the court. It was further agreed that the hours of the clerk of the court will be 8:00 a.m. - 4:00 p.m. While the court has the primary responsibility to manage the responsibilities of the clerk of the court, we concur that the Village has an obligation to undertake an appropriate investigation when its employee (the court clerk) has a complaint of harassment. While we recognize the right of Village of Corfu to respond appropriately to harassment complaints, the Village of Corfu has no authority to sanction or censure Justice Alexander or to remove him from public office. Jurisdiction and oversight of judicial conduct matters rests solely with the Judicial Conduct Commission.

This will also confirm that at our meeting, we indicated that Justice Alexander has no right to terminate his court clerk without approval of the Village Board of Trustees. We further indicated that Justice Alexander cannot prohibit his court clerk from talking to the Village Board. At the same time, the court clerk may not reveal to the Village Board any confidential information relative to court cases. Furthermore, the court clerk may not comment on any decisions made by Justice Alexander relative to cases handled by the court.

With respect to complaints by Justice Alexander concerning the court clerks' handling of a particular traffic matter, we view it as a minor issue that requires no further action. We wish to emphasize the obligation of the court to maintain its regularly scheduled court calendar. In particular, last minute cancellations of court are not acceptable, especially when a large number of cases are scheduled.

The overriding discussion focused on the need of both the Village Board of Trustees and the Village Justice Court to move beyond the personnel disputes of the past several months to assure the smooth orderly operation of the court going forward.

While it was not discussed at our meeting, we recognize and acknowledge that the underlying issue of the audit findings remain unresolved. In particular, we urge the Village and the Justice Court to take appropriate steps to resolve the issue of missing funds. We do not dispute the findings of the State Comptroller and emphasize that under New York State law Village and Town Court Justices are liable for shortfalls in their revenue and bail accounts. Appropriate steps must also be taken to assure that adequate internal controls are in place at the Village of Corfu Justice Court. Given the prior findings in the audit, the Village should expend appropriate resources to perform an annual audit of the court as required under the Uniform Justice Court Act.
