

# Village of Corfu Regular Minutes Public Hearing for Local Law #1 of 2024 February 14, 2024

The Village of Corfu held its Regular Meeting and Public Hearing for Local Law #1 of 2024 on February 14, 2024, at 6:30 p.m. at located at 116 East Main St, Corfu NY 14036.

In attendance: Mayor Sargent, Deputy Mayor Doktor, Trustee Krzemien, Trustee Lauer Also in attendance: Clerk, Jennifer Eck, Maintenance, Loren Vinent, Officer in Charge, David Krzemien, Daily News reporter. Trustee Reisdorf was absent.

Mayor Sargent read Local Law No. #1 of the year 2024 and opened the public hearing. Village of Corfu, County of Genesee

A local law authorizing a property tax levy in excess of the limit established in General Municipal Law §3-c

Section 1. Legislative Intent

It is the intent of this local law to allow the Village of Corfu to adopt a budget for the fiscal year commencing June 1, 2024, that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

#### Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body. Section 3. Tax Levy Limit Override

The Board of Trustees of the Village of Corfu, County of Genesee, is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2024, that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

#### Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

#### **Planning and Code Enforcement:**

- Planning Board is meeting on Thursday and will be discussing Outpour Ministries; there is a concern of no lighting in parking lot which could be a hazard and the tenants are concerned.

- Officer in Charge Krzemien has been asked to join the Criminal Justice Advisory Committee in Genesee County
- The department has been notified by the State as to the reasoning for the denial of grants; denials are based on the number of accidents in the jurisdiction.
- Traffic stops have decreased.
- Vehicle updates:
  - Car #1 has an exhaust manifold leak.
  - New car is running well; computer is being installed, radar unit installed and needs certification.
- AED unit was down for a short period of time; now in service.
- Spike strips have been utilized a number of times.
- Qtrly training is scheduled for this Saturday.
- Officer Givens is attending Instructor Development School; will now have 4 instructors in Dept.
- GCC is offering a Human Trafficking Seminar which Officer LaBelle will be attending.
- Maintenance replaced door lock on shop.
- Trustee Krzemien questioned the procedure of scheduling Officers; Mayor is in charge of the scheduling; Officers notify Mayor by the 20<sup>th</sup> of the Month their availability and the schedule is based on seniority. If there are open shifts, Officers can fill up the schedule. Genesee County allows for Officers to work 19 ½ hours per week.

BE IT FURTHER RESOLVED that a certified copy of said Local Law #1 of 2024 be filed with the New York State Secretary of State in accordance with Law.
