Resolution to Introduce Local Law No. #1 of the year 2013

Village of Corfu, County of Genesee

A local law authorizing a property tax levy in excess of the limit established in General Municipal Law §3-c

Section 1. Legislative Intent

It is the intent of this local law to allow the Village of Corfu to adopt a budget for the fiscal year commencing June 1, 2013 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

Section 3. Tax Levy Limit Override

The Board of Trustees of the Village of Corfu, County of Genesee, is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2013 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

Public Hearing for Tax Cap Override was closed at 7:25 pm.

It was mentioned that Maintenance department has turned in their budget requests. They will be discussed during budget portion of meeting.

Clerk mentioned Police Administrator has been contacted to arrange for coverage for the corner on Tuesday morning when Crossing Guard Charlie Lenhard will be unable to cover.

Mayor Skeet gave brief update of the Joint Sewer meeting the previous week. Discussion took place regarding the Village having to apply for a Bond Anticipation Note (BAN) due to the nature of the grant. The way the grant is structured the Village would have to pay contractors etc. first, and then would get reimbursed. It was mentioned that the Grant reimbursements are paid by the quarter so money would have to be available initially for the bill payments prior to reimbursement and that a separate checking account would have to be set up. It was also mentioned that the DEC keeps 10% until the final review.

Trustee Peterson questioned if the bank account that is set up could be an interest bearing account. It was decided to have the representative from Municipal Solutions that spoke at the Town meeting come in to the next Village Board meeting to educate the Board and clerks on the process that will need to be followed for the BAN and checking account.

Trustee Peterson asked if an itemized estimate was received from Marchese Computers regarding a server. Clerk informed him it has been received and the office is currently awaiting another estimate from Alternative Information Systems and both could be reviewed at the same time.

Trustee Ianni mentioned he would like to have the Board send a Thank you to the Town of Pembroke Board for their assistance and cooperation on the skating rink. He said it has been used quite frequently. Clerk will draft a letter to the Town Board.

Clerk questioned if the Board had any questions or requests for Code enforcement officer John Good to include on letters being sent regarding unsafe buildings. The Board had none.

Budget portion of meeting began at 8:06 pm.

Trustee Peterson distributed budget requests from Judge Alexander for the Court portion of the budget. The Judge's requests for increases in Justice and Acting Justice salaries were briefly discussed. Lengthy discussion also took place regarding the judge's budget suggestion to split the court clerk from a full time position to two part-time 20 hour court clerks.

Judge Alexander's request suggested that court equipment and contractual portions of budget remain the same as the previous year. Clerk mentioned based on this years average expenditures some increase in the court contractual budget would be suggested for additional postage and prosecutor fees. No decisions were

made on the Court budget until more detailed information is presented at the next budget meeting.

Copies of Maintenance department equipment requests were distributed to the Board. Items suggested to be put out for bid and replacement equipment were listed. After some discussion of the uses of and needs for the equipment it was decided to table the equipment discussion until Trustees Ianni and Peterson had an opportunity to speak with Mike and Jesse regarding their requests.

Clerk mentioned that she had spoken with Ed Mileham from the Town. He said their Board has a workshop on Thursday and that he would contact her on Friday regarding any rent increase after speaking with the Board.
