

Village of Corfu Regular Minutes Budget Workshop March 13, 2024

The Village of Corfu held its Regular Meeting and Budget Workshop on March 13, 2024, at 6:30 p.m. at located at 116 East Main St, Corfu NY 14036.

In attendance: Mayor Sargent, Deputy Mayor Doktor, and Trustee Lauer. Also in attendance: Clerk, Jennifer Eck, Maintenance, Loren Vinent, Electrician, Norm Waff, Code Enforcement, Robin Johnson, Planning Board Rep, Kyle Wruck. Trustee Reisdorf and Truste Krzemien were absent.

Mayor Sargent called a Moment of Silence for Officer Sanfratello.

Planning and Code Enforcement:

- Chairman, Mark Zimmerman will be sending a letter to owner of 47-49 West Main for updates on site plan per requested from previous development; fencing, and lighting.
- Tenant for 47-49 has submitted lease to owner; they currently have 12 sites that are rotated for events and are classified as a Church.

- MRB is collaborating with Clark Patterson regarding the Darien project for efficiency of the new plant.
- Darien is reviewing the current IMA agreement with Town of Pembroke for their reference.
- Mr. Waff has been collaborating with MRB and documenting issues with the contractor; original plans are not being followed.
- Need to complete the transfer from the Sewer Fund to General Fund for the \$25,000 loan at 7% interest rate before the end of the fiscal year.

- Sealing for driveway to be split between, Sewer, Maintenance and Police \$10,000.
- Questioned the transportation contractual line Still utilizing Camden Group, will need to increase this line.
- Would like various tax rates and quotes for fund balances.
- Trustee Lauer would like accountant to review the sewer rates and help decide which rates are better for the consumer.
